Cruz for President, FEC ID# C00574624, is in receipt of your Request for Additional Information dated July 30, 2015, regarding the Committee's Amended July Quarterly Report (04/01/2015 – 06/30/2015).
The Committee has reviewed the July Quarterly report and resolved the Detailed Summary Page itemized contribution total. The Committee will amend the 2nd Quarter 2015 report to reflect those updates.

In accord with 11 CFR 110.1(g), the committee takes the following steps to attempt to determine the permissibility of contributions from limited liability companies:

The committee conducts a search of public information in an attempt to determine if a particular entity is listed as a corporation under the laws of the state in which it resides.

The committee also sends a follow up letter to the donor which informs the donor of the law relative to limited liability companies and that requests proper donor attribution for the contribution.

If the committee has any information indicating the contribution is impermissible, a refund is issued within 30 days of the committee making this determination.

With respect to the specific limited liability company transactions you reference, the committee has taken all of the above actions to determine their permissibility and will act accordingly relative to any information it receives from the donors.
