
Dear Sir:

The National Republican Senatorial Committee (NRSC) has discovered a discrepancy in the aggregate y-t-d per election for office sought in Oklahoma. We originally filed a notice on 10/5/04 for a direct mailing done in Oklahoma by Creative Direct. That notice stated the amount of the expenditure was \$48,960.00. We filed a letter stating that the correct amount of the expenditure was in fact \$47,845.82. Unfortunately, we did not provide an accurate aggregate y-t-d figure on that letter and that caused each subsequent notice to contain an incorrect aggregate y-t-d figure. Here are the correct aggregate figures beginning with the notice filed on the 5th and ending with the notice filed on the 16th:

Date filed: 10/5/04, aggregate y-t-d per office sought: \$672,745.82
Date filed: 10/8/04, aggregate y-t-d per office sought: \$720,591.64
Date filed: 10/12/04, aggregate y-t-d per office sought: \$768,437.46
Date filed: 10/13/04, aggregate y-t-d per office sought: \$909,829.46
Date filed: 10/16/04, aggregate y-t-d per office sought: \$1,261,651.46

We will make sure to carry over the correct aggregate y-t-d per office sought on any future notices. We apologize for any confusion that this discrepancy might have caused.
