
Dear sir or madam:

It has come to our attention that Sandler, Travis & Rosenberg, P.A. Political Action Committee ("STARPAC") has inadvertently given campaign contributions to the Demint for Senate Committee Inc that exceeded the Federal limits set forth in 2 U.S.C. § 441a(a). We therefore request a refund of the excess amount totaling \$2,700.00.

STARPAC is a non-multicandidate political committee and as such may contribute \$2,300 per election. STARPAC contributed a total of \$5,000 (\$1,000 on December 6, 2006; \$2,000 on March 22, 2007; and \$2,000 on March 14, 2008) to Demint for Senate Committee Inc. for the 2010 General election.¹ Thus, STARPAC requests a refund of \$2,700, the amount of the contribution that exceeded the \$2,300 limit.

Your letter dated March 27, 2009 brought to our attention the fact that certain contributions made by Sandler, Travis and Rosenberg P.A. Political Action Committee ("STARPAC") may have exceeded the limits set forth in 2 U.S.C. § 441a(a). We investigated the contributions in questions and upon further review it appears that STARPAC did, in fact, exceed the applicable contribution limits.
