Dear Ms. Wilkens:

Thank you for your assistance in helping the America West Airlines, Inc. Federal PAC respond to the items in your letters of July 23, 1997. I am attaching the appropriately amended PAC reports, which have been submitted by Mr. C. A. Howlett, the PAC Treasurer. The amended reports should answer your concerns as communicated by your three letters and our subsequent phone conversations.

April 1996 Quarterly Report

1. The error in listing contributions has been corrected. Since this affected subsequent reports, they have been amended as well to reflect the new totals.
2. Schedule B has been amended to reflect the purpose of the contribution by designating it as a general election contribution.
3. The PAC now understands that it must separate contributions exceeding \$200 from those that don't. At your direction, future reports will follow that procedure.

July 1996 Quarterly Report

1. The July 1996 and Year End 1995 reports now distinguish between primary and general election contributions. This clarification now demonstrates that the PAC did not exceed the \$1,000.00 limit per election in either the primary or the general elections for the candidates in question.

January Year End Report for 1995

1. As mentioned above, the PAC now understands that it must separate contributions exceeding \$200 from those that don't. Future reports will follow that procedure.
2. Schedule B has been amended to provide the purpose for each disbursement.

Please accept my apologies for the PAC's delayed response. Mr. Howlett and I have been on business trips, and I was ill for a week. These things prevented our getting together to address these issues as quickly as we would have liked.

Again, thank you for your help with all of this. I believe the PAC has responded to all of your requests. If we need to do anything further, or if you require additional information, please don't hesitate to call me or the PAC Treasurer, Mr. Howlett.
