-Your calculations for Lines 7 and 23, Column B appear to be incorrect. FEC calculations disclose these amounts to be \$78,114.16 and \$60,500, respectively. Please provide the corrected totals on the Summary and Detailed Summary Pages.

-Your report disclosed a category of financial activity that has been reflected on the wrong line of the Detailed Summary Page. Contributions to Non-Federal Candidates should be properly disclosed on a separate Schedule B, supporting Line 29 of the Detailed Summary Page. Please refer to the instructions contained on the forms to determine the proper categorization when preparing your next filing.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
