In response to the letter dated October 16, 2002 from the Federal Election Commission (FEC) to the National Association of Chain Drug Stores Political Action Committee (NACDS-PAC) regarding impermissible contributions to Rep. Vic Snyder (D-AR), Rep. Don Manzullo (R-IL) and Sen.
