This responds to your letter concerning the above referenced FEC report.

With respect to Items 1 & 2 concerning Schedule B and Schedule D, the Committee's report included on the FEC website does not include pages 155-172 of the report. Inclusion of these pages would answer your concerns concerning the MEMO entries on Schedule B and the payments reported on Schedule D. Although we are confident that these pages were included in our original submission, we have amended our February Monthly Report to include the missing pages.

With respect to Schedule F, supporting Line 25, we amended our 30 Day Post-General Report (10/19/06 – 11/27/06) to include as a memo entry the coordinated expenditure made after the general election date for Jack Carter. Schedule D was also amended to correctly reflect the outstanding debt. The Year End Report, Schedule D was also amended to correctly reflect the outstanding debt. The February Monthly Report, Schedule F, supporting Line 25 has been amended to include the date the expenditure was incurred as well as the date of the actual disbursement. Schedule D has also been amended.
