Dear Ms. Needles:

We were notified by Congressman Charlie Melancon's campaign office today of a problem with PAC checks issued by the American Crystal Sugar Political Action Committee. Because of the complexity of the situation, I felt a letter was necessary explaining the amendments.

On November 11, 2005 a \$5,000 check was issued to Congressman Melancon for the 2006 Runoff Election. Congressman Melancon's office later requested the check be re-designated to the 2008 Primary Election. This was granted, however, through an oversight it was not changed on our PAC system. Because this change was not made on our PAC system, two more checks were issued, one on March 28, 2007 for \$1,000 and one on April 19, 2007 for \$4,000 for the 2008 Primary Election and a check for \$1,000 was issued to the 2008 General Election.

We have authorized Congressman Melancon's office to re-designate check #8218 dated March 28, 2007 for \$1,000 and check #8233 dated April 19, 2007 for \$4,000 to the General Election and have voided out check #8234 dated April 19, 2007 for \$1,000 for the General Election that was never cashed.

Amendments were electronically filed on July 9, 2007 for the November, 2005, March, 2006 and April, 2006 FEC Reports.
