The committee and the association, its connected organization (Financial Service Centers of America, Inc.), both use the same bank, BB&T. The committee's treasurer learned of this inadvertent error days later, consulted outside counsel, and immediately transferred the mis-deposited funds to the association's account on January 29, 2018. The treasurer has clarified the committee's policy regarding deposit of committee funds with association staff to prevent a future recurrence of this inadvertent error.

On January 22, 2018, association staff inadvertently made two deposits of association funds (\$12,500 and \$24,090) into the committee's account. The committee and the association, its connected organization (Financial Service Centers of America, Inc.), both use the same bank, BB&T. The committee's treasurer learned of this inadvertent error days later, consulted outside counsel, and immediately transferred the mis-deposited funds to the association's account on January 29, 2018. The treasurer has clarified the committee's policy regarding deposit of committee funds with association staff to prevent a future recurrence of this inadvertent error.
