On February 15, 2005, the Progressive Patriots Fund received a request for additional information in response to their Statement of Organization filing on January 21, 2005. The letter requested that an amendment be filed pursuant to FEC guidelines that the original Statement of Organization must be signed by the Treasurer. On the original filing, the Assistant Treasurer, acting as the Designated Agent for the Treasurer, signed the form (Attachment #1). At that time the Progressive Patriots Fund was under the impression from the FEC Campaign Guide for Non-Connected Committees (Attachment #2, Signing and Dating the Form) and the FEC Information Division that this was permissible.
