Thank you for the opportunity to articulate that Blakeman 2014, Inc. has actively tried to acquire and report concerning each contributor's name, address, and employer/occupation information.

Blakeman 2014, Inc. meets the guidelines of 11 CFR 104.7. Specifically, Blakeman 2014, Inc. (the "Committee") undertakes the following actions:

1. The Committee's original solicitation includes a clear and conspicuous request for the contributor information and informed the contributor of the requirements of federal law for the reporting of such information.
2. When such information was not provided, the Committee made at least one follow-up, stand-alone effort to obtain said information.
3. The follow-up effort must occurred before 30 days after receipt of the contribution and was in the form of a request via mail, e-mail, or telephone documented in writing. Said requests included the following:
  - a. An inquiry for the missing information, without soliciting a contribution.
  - b. Notification to the contributor that the requirements of federal law for the reporting of contributor information.
