This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 1 item(s):

- Schedule A supporting Line 17 of your Detailed Summary Page discloses a receipt for "cash on hand adjustment:in response to rafi - see attached memo" for \$3,416.20. In memo text you state, "In reference to the rafi regarding negative balance on reporting period ending June 30, 2019 the Committee has completed due diligence attempting to find errors in reports and has not been able to do it. The correct ending balance (coh) at the close of that period is \$2290.25. The Committee has amended the report. Thank you.". Please provide any clarifying information as to the details of this receipt and why this activity was not disclosed on the original report covering the period during which it took place.

**Please note, you will not receive an additional notice from the Commission on this matter.** Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just
