Dear Ms. Beaufort:

The Cotton for Senate is in receipt of your request for additional information, dated August 17, 2014.

Cotton for Senate has reviewed our 48 hour notices and it appears that page 4 of our disclosure filed on 5/14/2014 is not included on the FEC's website. Page 1 is included twice but page 4 is missing. The Committee filed this on time and believes a page may have been misplaced by the Secretary of the Senate. In the interest of full disclosure, we have attached that missing page to this letter. The Committee is reviewing our procedures for the upcoming General Election 48 hour period to ensure compliance with disclosure requirements.

Cotton for Senate is aware that earmarked contributions that aggregate to more than \$200 in contributions during the election cycle are to be itemized on disclosure reports. The Committee understands that these itemizations should include the full name, mailing address, employer and occupation of each contributor, along with memo text identifying the contribution as an earmark. Any un-itemized contributions received through the conduit are included in our totals on line 11(a)ii). Additionally the Committee understands that the conduit must be itemized as a memo entry on Schedule A disclosing the total amount of earmarked contributions received from the conduit. The Committee has reviewed the report and can further confirm to the FEC that all contributions that were required to be itemized were, in fact, itemized on the report. Cotton for Senate will continue to accurately report and itemize all such earmarked contributions on future reports.

The Committee believes that no further action is required at this time.




