
Dear Ms. Della Rocco:

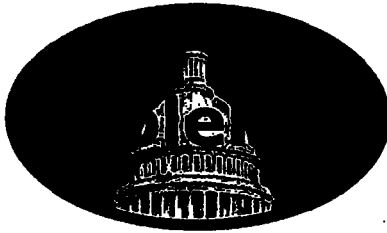
We trust these actions have adequately addressed the issues raised in your letter.


