We are in receipt of your letter dated June 12, 2009 asking for additional information for the above referenced report. As you may already know, the accountant who assisted in the preparation of this and other reports during the 2008 campaign died suddenly and left things in disarray. We understand that the treasurer is the ultimate responsible person but once the CPA died his office was sealed and she was left without certain data necessary to properly proceed. Once again we apologize for any inconvenience this may have caused and we are making every effort to properly comply.

- I. We have amended the October Quarterly closing balances. In addition we amended the October Quarterly reflect opening and ending cash reflected twice. We have amended the October Quarterly Report (08/27/08 - 09/30/08) to properly reflect opening and closing balances. In addition we amended the 12 Day Pre-General Report (10/01/08 - 10/19/08) to properly reflect opening and ending cash balances as well. The main error here was a \$340 disbursement
- c) cy 24 hour report; the disbursement to Event Radio, Inc. was for walke talkies used at a rally for crowd 2. control. It was the opinion of the treasurer based on the definition of independent expenditures that this expenditure did not expressly advocate the election or defeat of a candidate as defined on page 18 of the instructions.
  - 3. 48 hour report; the disbursement to Cybervision Entertainment was for cable and harware used in fund raising for entertainment purposes and does not fall under the definition of an independent expenditure. According to the treasurer's understanding the expenditures to John Skvarla, Steven Dawes and to John Maner for t-shirts and signs did not fall under independent expenditures because these items were produced and sold and therefore not a form of communication; similar to a retail store selling a t-shirt with a logo or design. The store is not communicating anything but the wearer does. However on further review we have amended the report to reflect the adjustment.

    - 5. We have corrected the information in accordance with the instructions.

As a result of making the required changes on the aforementioned report we found that the other reports had to be amended to reflect changes in line item balances and we have enclosed all amended reports with this report.
