Contributions to non-federal candidates/committees should be reported on Schedule B supporting Line 29. Please provide an amendment to properly disclose the nature of these transactions.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
