The reporting of \$5,000 as a primary in-kind donation was an error on my part. The donation was to be split between the primary and the general election as the in-kind research will be used in part in the primary and in part in the general election. This was understood by the donor and by the campaign at the time of the donation.

The report has been amended to reflect the original intent.

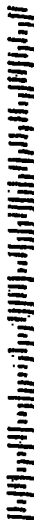
