Our records show that our check number 11383 was written on February 18, 2010 to the DSCC and forwarded to the committee. As of our bank statement closing May 31, 2010, the recipient committee has not cashed the check. During our monthly bank reconciliation process, we review all outstanding checks and consider whether or not they should be voided after 90 days and disclosed on the appropriate FEC and state campaign finance reports. We will issue a stop payment on the funds for this uncashed check.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
