Dear Mr. Kreske:

This letter is prompted by the Commission's review of your amended debt settlement plan (DSP). In order to complete our review, the following information is needed:

- On Line 6 of Part I, your amended DSP lists \$133,202.74 as the total amount of debts owed by the Committee. The Commission calculates the total debts listed in Part II and Part III of your amended DSP to be \$140,895.89. Please file an amended DSP to correct this discrepancy.
- On Line 7 of Part I, your amended DSP lists the total number of creditors owed by the Committee as nineteen (19). The total number of individual creditors listed in Part II and Part III of your amended DSP is eighteen (18). It appears you may have listed one creditor, CP Direct, twice. Please file an amended DSP, or an amended 2009 Year End Report, to correct this discrepancy.
- On Line 8 of Part I, your amended DSP lists the total number of creditors in Part II of your amended DSP as eleven (11). The total number of individual creditors listed in Part II of your amended DSP is fourteen (14). Please file an amended DSP to correct this discrepancy.
- On Line 9 of Part I, your amended DSP lists \$73,792.76 as the amount owed to creditors in Part II of the amended DSP. The Commission calculates the total debts listed in Part II of your amended DSP to be \$81,485.97. Please file an amended DSP to correct this discrepancy.
- In Part II of your amended DSP, you list a debt owed to John A. Livingstone of \$1,965.49. Your 2009 Year End Report lists the debt owed to John A. Livingstone as \$1,985.14. Please file an amended DSP, or an amended 2009 Year End Report, to correct this discrepancy.
- In Part II of your amended DSP, you list a debt owed to Elizabeth A. Livingstone of \$1,992.84. Your 2009 Year End Report lists the debt owed to Elizabeth A. Livingstone as \$2,012.77. Please file an amended DSP, or an amended 2009 Year End Report, to correct this discrepancy.
- In Part II of your amended DSP you have reported an agreement with creditor Brian Anderson, but the agreement is not signed by the creditor or the creditor's representative. All debt



settlement agreements listed in Part II require the creditor's signature to be considered valid. Please file an amended DSP to correct this omission.

Unlike previous election cycles, you will not receive an additional notice from the Commission on this matter. If the information is not provided, the processing of the DSP will be discontinued. You are reminded that until the Commission is able to complete its review, all debts including the debts involved in the DSP must be continuously reported. (11 CFR §104.11)
