On Tuesday, April 27, we received a letter from you explaining that the Career College Association Political Action Committee (CCAPAC) has exceeded the legal limit for contributing to the general election fund for "Buck McKeon for Congress". The excess amount was for \$2,500. We contacted the McKeon campaign to request that our contributions for the current election cycle be re-allocated so we are not outside the legal limit, and they indicated that they will comply with our request. Our new allocation is \$5,000 for the general election fund and \$5,000 for the primary election fund.

We have attached a copy of our letter to the McKeon campaign, and we hope that this letter, along with our amended FEC report, has adequately addressed the concerns of the FEC regarding this matter.
