July Monthly Report (6/1/2011-6/30/2011)


ASAPAC disclosed on Schedule E what appeared to be an excess of contributions to Martha Roby for Congress. Martha Roby for Congress automated a redesignation of a contribution from ASAPAC for 2010 Debt Retirement to 2012 Primary Contribution without our knowledge. The report also included an error of a future transaction of 11/10/11 for \$5,000 to the Martha Roby Campaign for 2012 Primary Contribution.

We would like to respond to you that we have amended this report on October 3, 2011 by deleting the error contribution. We have also amended the 30-Day Post-General on October 3, 2011, to amend the designation of the original contribution on 11/10/10 of \$5,000 to Martha Roby for Congress to 2012 Primary Contribution. The October Monthly will include a redesignation of the 2/16/11 contribution of \$1,000 to Martha Roby for Congress to 2012 General Contribution.

Enclosed, please find a copy the letter to Martha Roby for Congress informing them of the redesignation.

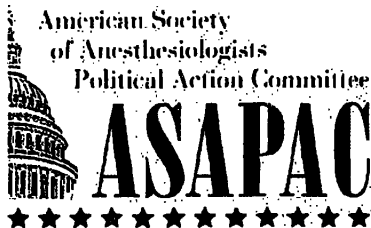
