This letter is prompted by the Commission's preliminary review of the Report of Independent Expenditures Made and Contributions Received (FEC Form 5) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **An adequate response must be received at the Commission by the response date noted above.** Additional information is needed for the following 2 item(s):

1. Please provide a Schedule 5-A to support the amount disclosed on Line 6 of FEC Form 5. Each contributor who made a donation in excess of \$200 used to fund the independent expenditure must be itemized on Schedule 5-A, including their identification information. Please amend your report to provide the missing information. (11 CFR § 109.10)
2. Please provide a Schedule 5-E to support the amount disclosed on Line 7 of FEC Form 5. For quarterly reports, independent expenditures aggregating in excess of \$250 during the calendar year, per election, per office sought must be itemized on Schedule 5-E. For 24 and 48-Hour Reports, itemization is required on Schedule 5-E for all independent expenditures disclosed on Line 7.

All independent expenditures requiring itemization on Schedule 5-E must the full name and address of the payee, the date, the amount, the aggregate calendar-year-to-date total, the purpose, the election, and the name, office sought, state, and district of the federal candidate supported or opposed by the expenditure. Please amend your filing to correct this discrepancy. (11 CFR § 109.10)


