Dear Mr. Goode,

It has recently been brought to our attention that APMAPAC is in violation of federal regulations with respect to campaign contribution to your campaign. Our committee cut a contribution of \$2,500 to the campaign, designated for the primary election, back in June 2014. Because this donation was received by your office after the primary election had occurred, the donation was designated to the general election. Having not known that a re-designation had been made, in August 2014 we made an additional contribution of \$5,000 to the campaign, designated for the general election.

This means we have inadvertently contributed \$7,500 to Pallone for Congress for the general election, putting us in violation of federal regulations.


To correct this error we, unfortunately, must request a refund of \$2,500 to put us back in compliance with federal law.
