This memo text references the FEC's May 23, 2008 preliminary review letter to the International Union of Operating Engineers/Engineers Political Education Committee (IUOE/EPEC) concerning the April Monthly Report (3/1/07-3/31/07) of IUOE/EPEC. Item 1: The unitemized receipts include \$2,335.20 that was deposited into IUOE/EPEC when an employer, Sheehan Pipeline Construction Company, sent a single check to IUOE/EPEC that represented both voluntary payroll deductions from the paychecks of IUOE members (federally permissible source) and contributions to the IUOE & Pipeline Contractors Association's National Training Fund. The employer's combined check was made payable to IUOE/EPEC. The contributions to the training fund are part of the employees' compensation package and are based on the number of hours worked by employees covered by a collective bargaining agreement between the IUOE and the employers. On June 3, 2008, the IUOE/EPEC hand-delivered to the IUOE & Pipeline Contractors Association's National Training Fund the training fund portion of the deposit, along with an interest payment of \$4.25, for a total of \$2,339.45. The unitemized receipts also include \$562.55 that was deposited into IUOE/EPEC when an employer, Laney, Inc., sent a single check to IUOE/EPEC that represented voluntary payroll deductions from the paychecks of IUOE members (a federal permissible source) and contributions to the Central Pension Fund (CPF). The employer's combined check was made payable to IUOE/EPEC. The contributions to the pension fund are part of the employees' compensation package and are based on the number of hours worked by employees covered by a collective bargaining agreement between the IUOE and the employers. On June 9, 2008, the IUOE/EPEC sent to Laney, Inc. a check in the amount of \$563.57, which includes the \$562.55, along with an interest payment of \$1.02. IUOE/EPEC did not forward this pension amount to the CPF, because the employer had already paid the pension fund the amounts owed to CPF. The remaining amount of \$69.46 in unitemized receipts was received from various individual IUOE members who contributed amounts that fell below the \$200 itemization threshold. IUOE/EPEC incorrectly reported these amounts on Line 17 of the April Monthly Report for 2008. These receipts (\$69.46) were moved to Line 11(a)(ii) on this amended April Monthly Report. Items 2 & 3: the letter stated that the occupation and name of employer are required for individuals who contribute more than \$200, and that some individuals' records in Schedule A supporting line 11(a)(i) lacked this information. All of the individual records have been corrected on this amended report. Item 4: The letter asked IUOE/EPEC to amend by providing the purpose of disbursement for each disbursement itemized on Schedule B supporting line 29, and that our report disclosed a category of financial activity that was reflected on the wrong line of the Detailed Summary Page. All disbursements that were included on Line 29 display the purpose of each disbursement on Schedule B and are now reported correctly on Line 21(b) of the Detailed Summary Page on this amended report.
