As we previously discussed, Durkee & Associates was reasonable for filing FEC reports through August, 2011. Kinde Durkee was arrested on September 2, 2011 by the FBI and Durkee & Associates was out of business as of September 5, 2011.

In September 2011 I attempted to file the missing month of August 2011 and mistakenly mixed it the entire totals including State totals from the summaries Durkee & Associates emailed to me.

The financials prior to September 2011, we agreed would be frozen pending the outcome of the FBI investigation and any assets recovered.

My reports after the Durkee & Associates period started with a balance of zero.

I am reluctant to amend the August 1 thru August 31 report I filed in lieu of Durkee & Associates being out of business if it would alter subsequent accurate reports.


