This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule E of your report discloses \$7,136 in payments to your connected organization for independent expenditures in support of several candidates (pertinent portion(s) attached). 2 U.S.C. §441b prohibits a corporation or labor organization from contributing or expending funds for the purpose of influencing any federal election; however, a connected organization may pay for the solicitation and administrative costs of its separate segregated fund.


Please amend your report to provide the date of the activity conducted by your connected organization, noting that you must pre-pay your connected organization for the production of materials used to support federal candidates. Although the Commission may take further legal action concerning this matter, your prompt action will be taken into consideration.

-Please provide the total(s) for Line 28(a), Column B of the Detailed Summary Page. Note that changes in your figures may affect your Column B totals on this report and/or on subsequent reports.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days
