Re: 30 Day Post-general Report (10/14/10 - 11/22/10)

Dear Ms. Kelly:

This letter is in response to your review of the above reference report and the 48-hour reports of large contributions filed prior to the November 2, 2010 special general election.

The Commission's regulations require disclosure of contributions \$1000 or more within 48 hours of receipt, but permit the Committee thirty to sixty days to redesignate contributions appropriately. Each contribution listed in the letter was disclosed on the 48-hour reports in accordance with the contributor information available at that time. The Committee received information clarifying the contribution allocation on joint checking accounts and/or redesignations after the close of the 48 hour reporting period for some contribution checks. A discussion of each item is presented in chronological order below.

1. Charles R. Bailey (Item 1) and Caitlin M. Bailey (Item 2). The Committee received a joint contribution from the Bailey's in the amount of \$1750 on 10/24/10. The full contribution was disclosed on the 48-hour report from Mr. Bailey. Subsequently the contribution was redesignated to Mrs. Bailey.
2. Constance J. Milstein (Item 1). The Committee received this contribution in the amount of \$2400 on 10/13/10. The contribution was reported on the 12-Day Pre-General Report covering the period 10/01/10 - 10/13/10. Due to an inadvertent clerical mistake, the contribution received on 10/13/10 was mistakenly reported on the 48-hour report for 10/14/10.
3. James R. Six (Item 1) and Ginger A. Six (Item 2). The Committee received a joint contribution from the Six's in the amount of \$1000 on 10/25/10. The contribution was initially thought to be from Mr. Six and the contribution was attributed to him on the 48-hour report. Subsequent information received from the Six's clarified that the contribution is designated to Mrs. Six.



4. Virginia P. Snowden (Item 2). The Committee received a contribution via wire transfer from the contributor on 10/22/10. The contributor wired the funds into one of the Committee's bank accounts rather than issuing a check or processing a contribution via credit card. The treasurer was not aware that the contribution had been posted until the bank statement was received at the end of the month.

5. Alpha Natural Resources, Inc. Political Action Committee (Item 2). The treasurer was not aware that the expenses had been incurred and consequently did not receive a notice until after the election that such expenses for travel on 10/21/10 would be contributed in-kind to the Committee by the PAC, rather than billed to the Committee at the appropriate cost by the vendor. The in-kind notice is dated 11/09/10.


