After identifying a discrepancy between the amount the PAC was reporting to the FEC as cash-on-hand and the amount in the PAC's bank account, the Horizon Lines PAC instructed counsel to undertake a review of all PAC filings since 2007. This review identified 4 undisclosed contributions made by check to the PAC totaling \$9,500, a \$2,564.12 payroll deduction payment from Nov. 2008 (representing contributions from 50 employees) to the PAC that had not been reported, and a number of other contributions for nominal amounts that had been incorrectly reported. The Horizon Lines PAC has amended its FEC reports to reflect the inclusion of these amounts, but a \$891.92 difference remains. Following consultation with the FEC analyst responsible for reviewing the Horizon Lines PAC reports, a one-time adjustment for this amount has been made to this report in order to reconcile the PAC's FEC report with its bank statement.
