SUBJECT: Updating Mailing List Information

This responds to a recent letter (or other correspondence) from your organization to the Federal Election Commission (FEC), asking that we modify our mailing list to reflect a change in your organization's officers and/or address. It appears that the purpose of this requested modification may be to amend the records of a political committee currently registered with the FEC.

Please note that the Information Division's mailing list is largely derived from the FEC's database of official registration documents filed by political committees. Accordingly, any changes in committee information must be submitted by *the committee's treasurer* on an amended Statement of Organization (Form 1) or a letter signed by the treasurer indicating what changes are to be made to the committee's registration information (this method is available to paper filers only). This notification must occur within 10 days of the change in information.


As a protection to your organization and the integrity of the public record, we are unable to modify a political committee's reported address/officer information in response to unofficial or miscellaneous correspondence.
