ITEM #1

OUR "BEST EFFORTS" FOR OBTAINING MISSING INFORMATION INCLUDES THE FOLLOWING:

1) ORIGINAL SOLICITATION INCLUDES CLEAR AND CONSPICUOUS REQUEST FOR THE CONTRIBUTOR INFORMATION AND CONTRIBUTOR OF THE FEDERAL LAW REQUIREMENTS FOR REPORTING SUCH INFORMATION.

2) ONE STAND ALONE EFFORT, IN WRITING, IS MADE TO OBTAIN THE INFORMATION NO LATER THAN 30 DAYS AFTER THE DATE OF THE CONTRIBUTION. THIS WRITTEN REQUEST CLEARLY ASKS FOR THE MISSING INFORMATION, WITHOUT SOLICITING THE CONTRIBUTOR. THE CONTRIBUTOR IS INFORMED AGAIN OF THE FEDERAL LAW REQUIREMENTS FOR REPORTING SUCH INFORMATION, AND INFORMATION IS RETURNED BY AIR MAIL IN A REGISTERED, POSTAGE PAID RETURN ENVELOPE.

3) UPON RECEIPT OF THE MISSING INFORMATION, THE INFORMATION IS INCLUDED IN THE NEXT REGULARLY SCHEDULED REPORT AS AN AMENDED MEMO SCHEDULE A LISTING.

ITEM #2

THERE WERE NO EMPLOYEES WITH MORE THAN 25% OF THEIR TIME SPENT ON FEDERAL ELECTION ACTIVITY DURING THE REPORTING PERIOD.

ITEM #3

SCHEDULE B SUPPORTING LINE 21(B) OF THE REPORT FILED INCLUDES ONLY PUBLIC COMMUNICATIONS THAT ARE GENERIC AND DO NOT RELATE TO ANY CANDIDATE FOR FEDERAL OFFICE.

ITEM #4

SCHEDULE H4 OF THE REPORT FILED INCLUDES ONLY EMPLOYEES WITH LESS THAN 25% OF THEIR TIME SPENT ON FEDERAL ELECTION ACTIVITY DURING THE REPORTING PERIOD.

ITEM #5

SCHEDULE H4 OF THE REPORT FILED INCLUDES ONLY GENERIC EXPENDITURES AND DO NOT RELATE TO ANY CANDIDATE FOR FEDERAL OFFICE.

ITEM #6

SCHEDULE H4 CONTAINS REIMBURSED AMOUNT TO INDIVIDUALS IN EXCESS OF \$500. THE ORIGINAL REPORT HAS BEEN AMENDED TO INCLUDE, AS MEMO ENTRIES, THE ORIGINAL VENDORS AND ALL REQUIREMENTS FOR THOSE VENDORS.
