In response to your April 28, 1999 letter, please be advised that the two contributions to candidates for state office: Committee to Elect Robert F. Kiss and to Friends of Joe Meyer, presumably were not necessary to be included in line 23 of our report to the Federal Election Commission since neither of the individuals was seeking federal office. The contribution to Talent for U.S. Congress should be deleted from line 23 because the check actually was never delivered to Mr. Talent. With regard to the \$1,000 contribution to the Alan Mollohan for Congress Committee, this disbursement should be redesignated for Congressman Mollohan's 2000 primary campaign.

Please clarify whether this is a federal committee(s), as there does not appear to be a committee(s) registered with the Commission under this name(s). In the event this is a non-federal committee(s), please disclose it on Schedule B supporting Line 29 of the Detailed Summary Page.
