In response to your letter dated September 22, 2011, regarding the above-referenced report, Gentiva Health Services Inc./GentivaPAC has submitted an amended report in its entirety today, October 6, 2011. The amended report corrects two entries that were incorrectly disclosed in the 2011 Mid Year Report. The 2011 Mid Year Report inadvertently listed a contribution to Bill Nelson for a primary election when it should have been listed for general election; and it incorrectly listed a \$1,000 contribution to David Lee Camp as being for an election in the year 1000 instead of 2012.
