Dear Laura,

It has recently come to our attention that Secure America's Majority PAC (SAMPAC) inadvertently exceeded the federal limit in campaign contributions made by the Raytheon PAC (RAYPAC) for 2012.

It appears as though a donation for \$5,000 issued by RAYPAC in December 2011 was not deposited into the SAMPAC account until early January 2012. As a result, RAYPAC's later donation to SAMPAC of \$5,000 made in September 2012 caused the total amount within the 2012 calendar year to exceed the allowable contribution limit allowed by the FEC.

Please accept our sincerest apologies for any inconvenience that this error may have caused. Enclosed you will find a copy of the \$5,000 refund check from SAMPAC that was issued to RAYPAC for the excessive contribution. Additionally, you will find a copy of our letter of explanation to RAYPAC.


