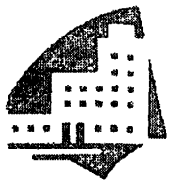

AMERICAN MAIN STREET, INC. CONSTITUTION AND BYLAWS

ARTICLE I – Name and Purpose

Section 1: Organization Name. The name of the organization shall be *American Main Street, INC., a Political Action Committee* and may be referred to as *American Main Street* or *AMS*.

Section 2: Purpose. The purpose of *American Main Street* is to advance the private business sector in a variety of areas from energy, finance, retail, automotive and a range of other areas. The organization focuses on removing the gap between the elected official and the people they represent by creating a direct line of communication to insure issues are resolved in a timely and effective manner beneficial to job-creators, their employees and the consumer. *American Main Street* will be involved in electing candidates and promoting issues that are more sensitive to the needs of the people the organization represent. Other primary objectives will be to eliminate poverty, create jobs, and strengthen the economy of the United States.

ARTICLE II – Organization Structure

Section 1: *American Main Street* shall be governed by a Board of Trustees to be elected by a majority vote of all paid members.

Section 2: The Board of Trustees shall consist of five (5) members. The positions shall be one (1) Educator or Education Administrator, one (1) Elected Official, two (2) At-Large Members, two (2) Local Businesspersons or Entrepreneurs. The Board of Trustees is responsible for setting the long-term goals of *American Main Street* and approving the employment of a President and CEO, contracted Senior Advisor and other employees as needed and deemed necessary by the Board of Trustees.

Section 3: The Executive Council of the Board of Trustees shall be elected by the Board of Trustees by a majority vote. The offices of the Executive Council shall consist of a Chair, Vice-Chair and Secretary/Treasurer. Elections will be held annually.

ARTICLE III – Employment

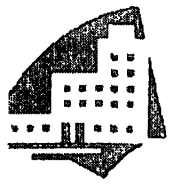
Section 1: *American Main Street* shall employ, if funds are available, a President and CEO and a Senior Advisor contracted independently of *American Main Street*.

Section 2: All employees and expenditures outside of day-to-day operation must be approved by the Board of Trustees.

ARTICLE IV – Duties

AMERICAN MAIN STREET, INC. CONSTITUTION AND BYLAWS

- A.) Chair: It shall be the duty of the Chair to set and lead regular meetings, set the agenda for regular and special meetings and to be available as necessary for the advancement of *American Main Street*.
- B.) Vice-Chair: The Vice-Chair shall be charged with serving as Chair in his/her absence, serving as an ex officio member of all committees and to be available as necessary for the advancement of *American Main Street*.
- C.) Secretary/Treasurer: It shall be the duty of the Secretary/Treasurer to keep track of all actions during regular and special meetings, submit meeting minutes to all members, maintain fundraising numbers, file reports with the Federal Elections Commission, develop an organization in consultation with the Board of Trustees and to be available as necessary in for the advancement of *American Main Street*.

Section 2: Employees.

- A.) President and CEO: The President and CEO shall be charged with overseeing the day to day operations of *American Main Street* and will serve as an ex officio member of the Board of Trustees. He or She will be responsible for fundraising efforts, selecting competent staff members, reporting regularly to the Board of Trustees and to be available as necessary for the advancement of *American Main Street*.
- B.) Senior Advisor: The Senior Advisor shall be contracted with the organization and shall be responsible for fundraising and setting overall political strategy in consultation with the President/CEO and Board of Trustees. The Senior Advisor will be in direct communication with elected officials, political organizations and *American Main Street* members and contributors. The Senior Associate will develop new programs and shall create a volunteer committee charged with testing and implementing these programs, reporting regularly to the President and CEO and the Board of Trustees upon request and be available as necessary for the advancement of *American Main Street*.

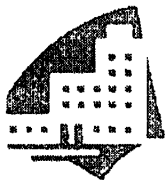
ARTICLE V – Community Action and Programs

Section 1: Programs shall be created by the President/CEO and Senior Associate and his or her appointed or elected committees.

Section 2: All new programs must be passed by a majority vote of the Board of Trustees.

Section 3: *American Main Street* will contribute to candidate's, candidate campaign committees, political organizations, community and charity groups, either directly, or indirectly, through a monetary contribution, a series of political advertisements and/or programs and events or other necessary means allowed by the Federal Elections Commission, that will advance the mission of *American Main Street* and best represent the members and contributors.

ARTICLE VI – Amendments

Amendments to this document must be submitted in writing to the President and CEO and the Board of Trustees sixty (60) days before the annual membership meetings. The amendment must be made available to all paid members by the President and CEO thirty (30) days prior to the meeting. The proposed amendment may be passed only by a 2/3 vote of all members present at an annual membership meeting.
