On May 29, 2013, pursuant to FEC advisory opinions and following consultation with FEC staff, Dominion Resources Inc. CT filed a statement of organization with the FEC in order to become a federal committee. Prior to that date, the PAC was registered and filed reports with the Connecticut State Elections Enforcement Commission in accordance with applicable law and its activities were limited to supporting qualified candidates for state offices. This is the first report being filed, and the memo entries for the individuals listed are to show where the funds came from within the existing PAC. All of the contributions comprising the unitemized transactions were under \$200 and were from individuals who are federally permissible sources.
