We write in response to your letter dated March 8, 2022, in which you inquire about a disbursement for “Administrative Recordkeeping 2017 – 2020” for \$9,654.64 on the 2021 Year-End Report submitted to the FEC by the ASCAP Legislative Fund for the Arts (the “Fund”) for the period 07/01/2021 – 12/31/2021.

The \$9,654.64 disbursement corresponds to recordkeeping and accounting services that the Fund’s treasurer, the undersigned, performed for the Fund during that timeframe while working for my regular employer, the American Society of Composers, Authors and Publishers (“ASCAP”). These services are detailed on the Schedule entitled “Prior Period Correction for 2017, 2018, 2019, 2020” attached as pages 2-3 of the Fund’s Miscellaneous Filing, dated July 23, 2021. On its initial reports, the Fund erroneously reported these transactions, which together equaled \$9,654,64, as in-kind contributions made by the undersigned personally. In a review of its operations, the Fund identified the errors, corrected the reports by removing the in-kinds through the Miscellaneous Filing, and paid ASCAP for the value of these same services through the disbursement referenced in your letter.

The Fund is committed to compliance with the Federal Election Campaign Act and the FEC’s regulations, and has revised its procedures to ensure that similar errors do not occur in the future. If you have further questions, please contact the Fund.

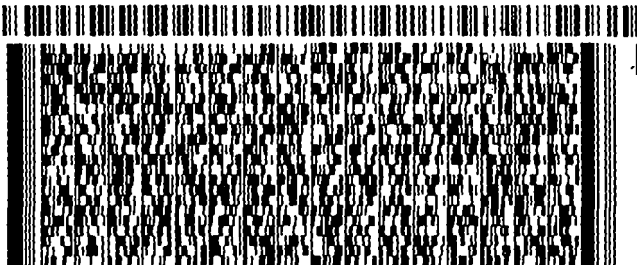

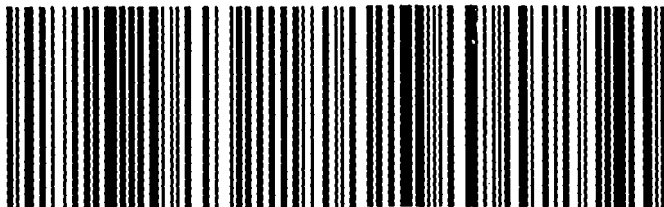

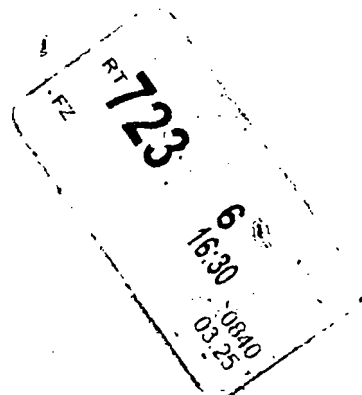
