Dear Mr. Ryan:

This letter responds to your letter of July 27, 2001 concerning the multicandidate filing status for Humane USA PAC, an issue about which we've had telephone conversations.

I have reviewed the filings of Humane USA PAC's previous treasurer and can only conclude that our 51st contribution was, in fact, received on or prior to September 18, 2000. I am enclosing on the following page a list of those contributors and the dates of their individual contributions. Perhaps the discrepancy in analysis of our records stems from the fact that contributors were not always listed in exact chronological order on each Schedule A Form Itemized Receipts. As you may recall, there were some previous reports for which activity was reported that occurred outside the reporting period. It may be the case that your analysis of our multicandidate status took place while those reports were being amended to place the contributions during the correct reporting period.

I hope this is a sufficient response to your inquiry and that HUMANE USA PAC's Multicandidate Filing Status will be considered approved. As always, I stand willing to answer any questions you have.
