The 2004 Post Election report was amended while the 2004 Year End report was not, creating a discrepancy in the cash on hand amount. The Year End report has now been amended, changing the cash on hand amount on line 6(b) to \$88, 957.32 for the May 20, 2006 report. This change corrected the inconsistency on Line 8 between current reporting period and closing calendar year-to-date cash-on-hand, as was requested in a letter from the Commission dated February 2, 2007. In addition, ACH deposits totaling \$18,731.08 were not calculated in line 6(c) of the original 2005 Pre-Election report due to user error and were added to the amended report received on 6/1/2006. These deposits changed the totals in lines 11(a)i and 11(a)ii, and therefore also changed the totals in lines 11(a)iii, 11(d), 19, and 20. These lines are being amended one last time on this report as the receipts reported were in error of +\$142.35.
