Dear Mr. Bennett:

I am writing in response to your letter of August 1, 2008 regarding our disclosure on FORM 1M. We have researched our records and provide the following information in response to your inquiry:

- Line 5(b). We had reported obtaining our 51<sup>st</sup> contributor on 6/30/06; you indicated Commission records indicate our committee did not receive its 51<sup>st</sup> contributor until 1/2/08. The attached list of itemized receipts from contributors indicates that the 51<sup>st</sup> contribution was in fact, made on 7/06/2006. (The FEC online list of individual contributors does not match the actual Item A "itemized receipts" list of contributors disclosed. See, e.g. 1<sup>st</sup> quarter 2004 report, which discloses a contribution from Jack Shumate, which does not show up on the list of individual contributors. ) As such, we have prepared an amended FORM 1M as attached, which will be filed, unless we hear otherwise from you.

Line 5(a). We have researched our records and confirmed that Commission records are correct. FORM 1M has been amended accordingly.

Line 5(d). We had previously disclosed a qualification date of 6/30/06 based on the mistaken date of the 51<sup>st</sup> contribution. As indicated above, this was actually achieved on 7/06/2006. FORM 1M has been amended to reflect the qualification date of 7/06/2006 accordingly.

Line 5(c). We had indicated our committee registration date was 3/27/2002, based on the date of our Statement of Organization, attached for your reference.



This letter is prompted by the Commission's review of the document referenced above. There appears to be a discrepancy between the information disclosed on your FORM 1M and Commission records that indicates your committee does not yet qualify for multicandidate status as defined by 11 CFR §100.5(e)(3). According to the available information, your committee does not meet the criteria for multicandidate status for the following reason(s):

-On Line 5(b), your committee discloses receiving a contribution from its 51<sup>st</sup> contributor on 6/30/06. However, Commission records indicate that your committee did not receive its 51<sup>st</sup> contribution until 1/2/08.

-On Line 5(a), your committee discloses making a contribution to Candice Miller on 12/31/04. However, Commission records indicate this contribution was made on 4/27/04 ✓

-On Line 5(d), your committee discloses a qualification date of 6/30/06. Please be advised that a committee's qualification date is the last date on which the committee has met all the multicandidate certification requirements. Therefore, the qualification date you have listed appears to be incorrect.

-On Line 5(c), your committee discloses a registration date of 3/27/02. ✓  
However, your committee registered with the Commission on 4/9/02.
