Our client, United Association Political Education Committee (UAPEC), has instructed us to respond to your notice dated April 17, 2008. We have enclosed a copy of that notice for your convenience.

The Mikulski for Senate Committee did refund to the UAPEC \$2,500. The money was received in March, 2008 and was reported on the April 20th 2008 monthly report. This money represents a refund of the February 13, 2007 contribution of \$2,500.

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following item:

-In response to an FEC inquiry regarding excessive contributions made to "BARBARA MIKULSKI" on your Year End Report (12/1/07-12/31/07), you submitted copies of redesignation letters, dated 2/29/08. These letters requested that the candidate redesignate contributions made on 3/25/05 and 12/7/07 to the 2010 Primary election and 2010 General election, respectively. However, your March Monthly Report (2/1/08-2/29/08) does not disclose these redesignations.

Please be advised, redesignations are reported as memo entries on Schedule B of the report covering the period in which the redesignation is made. Furthermore, a redesignation should occur within 60 days of the original contribution and include the amount and date of the original contribution, as well as the amount and date the redesignation is made. 11CFR§110.2(b)(5)(ii)(B) Please amend the appropriate report to disclose the redesignations or provide clarifying information.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an

enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. **Requests for extensions of time in which to respond will not be considered.**

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
