This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. Failure to adequately respond by the response date noted above could result in an audit or enforcement action. Additional information is needed for the following 2 item(s):

1. Line 5(e) indicates that your committee is a separate segregated fund. A separate segregated fund is a political committee established, financed, maintained or controlled by a corporation, labor organization, membership organization, cooperative or trade association.

If your committee is a separate segregated fund, then an amended Statement of Organization should be submitted which identifies the connected organization (11 CFR §102.2(a)(1)(ii)) and the type of connected organization. Moreover, in accordance with 52 U.S.C. §30102(e)(5), the name of any separate segregated fund is required to include the name of its connected organization. This includes any abbreviation within its title.

If your committee is not a separate segregated fund, an amended Statement of Organization should be submitted which indicates the appropriate type of committee. (11 CFR §102.2(a)(1)(i))

2. Line 6 of your Statement of Organization does not disclose the name of the connected organization of your separate segregated fund; additionally, you failed to identify the type of connected organization on Line 5(e). Please amend your Statement of Organization to clarify this apparent discrepancy. (52 U.S.C. §30103(b) and 11 CFR §100.6)

Requests for extensions of time in which to respond will not be considered.
