Dear Mr. Furman:

Thom Tillis Committee (FEC ID# C00545772) is in receipt of your letter dated September 10, 2013, with respect to the 2013 July Quarterly Report. Please accept this as our response to the FEC's request for additional information.

According to FEC regulations, when a committee receives an excessive contribution—one which exceeds the contributor's limit or the campaign's net debts outstanding for an election—the committee may remedy the violation by refunding the excessive amount or by seeking a redesignation or reattribution of it within 60 days.

All donations received that were in excess of the contribution limit were clearly marked on our disclosure report to confirm that the committee was in the process of requesting the required documentation for a reattribution or redesignation. If the Committee cannot obtain the needed documentation the committee refunds any impermissible excessive portion of the donation. If this process crosses a reporting period, the donation is marked with a memo text to show the committee is in the process of remedying the contribution and all additional transactions are reported on the next quarterly report.

For the donations listed in your letter I have included the current status of each contribution.

- [Wordsworth, Steve Mr. 6/21/13 \$2,800.00 P, 2014] – Redesignated \$200 to G2014 on 8/20/13
