This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:


Your report discloses several contributions to candidate committees for the retirement of debts incurred during the 1992 general election campaign. However, it appears that candidates D'Amato, Arney, and Murkowski had insufficient debts to warrant such a contribution. Please note that a committee may only designate contributions to retire a candidate's debt if those debts exist.

If the contribution(s) in question was incompletely or incorrectly disclosed, you should amend your original report with the clarifying information. If you have made an excessive contribution, you should either notify the recipient and request a refund of the amount and/or notify the recipient, in writing, of your redesignation of the contribution. All refunds must be made within sixty days of the treasurer's receipt of the contribution. Refunds are reported on Line 16 of the Detailed summary Page and on Schedule A of the report covering the period during which they were received. Redesignations are reported as memo entries on Schedule B of the report covering the period during which the redesignation is made. (11 CFR 110.2(b))

Although the Commission may take further legal steps regarding the excessive contribution(s), your prompt action in obtaining a refund and/or redesignating the contribution(s) will be taken into consideration.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
