

She was most helpful and said that we should file a Schedule B form to support line 29 of the Detailed Summary Page and that would satisfy the F.E.C. concern as to the itemization in the Report about our contribution to the Georgia G-8 PAC, a non-federal committee.

I have also contacted a representative of the G-8 PAC to get a letter from them to the effect that we made our contribution to G-8 under the assumption that they were indeed a federally registered political action committee.
