The Nick Casey for Congress committee (C00544221) filed a termination request on May 18, 2015 along with its July Quarterly report. That quarterly report reflected a zero balance. That termination was rejected due to the committee's involvement in MUR 6916.

Since those filings in May, the committee has had no financial activity – no receipts, no expenses, and no outstanding debts. Additionally, on August 16, 2015 the committee's Treasurer, Martin Glasser, passed away.

I hope that this letter will serve as a further confirmation of the committee's intent to terminate and that we have satisfied the requirements to terminate. If possible, since we are without our Treasurer, I respectfully request that the FEC grant an Administrative Termination of our committee.

Should the FEC require further action in order to terminate the committee please advise as to what steps are needed to take and how to do so.
