
The Form 3X for Strategy PAC was inadvertently filed after the April 15, 2014 deadline. I attempted to file the form electronically on April 12. Our software package, relatively new to us, indicated the form was filed. I forgot about the fact that the FEC sends along an email confirming receipt.

A few days later, a staff member noticed that the report was incorrect. I looked for the form on the FEC website, obviously without success. I inquired to our software provider, and received the following response: "Again, there are sometimes issues with the FEC's servers, internet connectivity, or other IT related problems that cause these rare occasions where a report isn't properly filed even though we receive a ping back from the FEC. The best way to be sure that a report is properly filed is to make sure you receive the confirmation message in Crimson Filer, the confirmation email from the FEC, and as an extra precaution to check the FEC's website."

Upon learning that, I immediately corrected the error mentioned above and filed the form on April 19. We received the following confirmation for the FEC: "Your filing was received and accepted by our system at 04/19/2014 - 10:28:37, and was assigned the Filing ID of: FEC-921762"

Again, the failure to file was inadvertent, Has not happened before, and will not be repeated.




