> This KeySpan Corporation Political Action Committee ('KeySpan PAC') termination report discloses a Line 21(b) cash on hand adjustment of -\$13,717.96 to correct accounting errors (described below) that occurred before the acquisition of KeySpan Corporation by National Grid USA. Following this corporate acquisition, National Grid USA Political Action Committee and KeySpan PAC became affiliated committees, as disclosed in amended Form 1 Statements of Organization. Later, National Grid USA became aware of a discrepancy between the KeySpan PAC bank balance and the cash on hand reported to the FEC. Due to National Grid USA's commitment to full compliance, this parent connected organization consulted outside counsel, froze KeySpan PAC's activity, and undertook an extensive review of KeySpan PAC's books and records, going beyond the required three-year document retention period to 2004, the oldest records available. With this filing, KeySpan PAC is disclosing the results of National Grid USA's review to bring the closing bank and FEC-reported balances into reconciliation and to request termination of the committee. As of June 6, 2013, the KeySpan PAC bank balance was \$8,574.91, with no outstanding receipt or deposit. Its last-filed FEC closing balance is \$22,292.87, representing a discrepancy of \$13,717.96. National Grid USA's financial review of KeySpan PAC's 2004-2013 financial records identified a net -\$4,075.52 that was disbursed without accurate disclosure to the FEC in Form 3X reports. The causes of these identified discrepancies include: 1. Checks that cleared the bank at amounts different than reported to the FEC; 2. Checks reported to the FEC that were never cashed: 3. Checks voided or never cashed but reported as disbursements to the FEC: 4. Receipt amounts that were not equal to PAC contributions reported to the FEC: 5. Disbursements reported without corresponding checks issued; and, 6. Disbursements reported twice at the same or different amounts. To the best of National Grid USA and KeySpan PAC's knowledge, based on the extensive financial review described above, the remaining -\$9,642.44 discrepancy occurred prior to 2004. No records from that period, pre-dating the August 24, 2007 KeySpan Corporation acquisition, are available. Questions regarding this matter should be directed to the KeySpan PAC Treasurer, Anne E.
