Dear Mr. Jones:

Thank you for your July 27, 2015 letter regarding the name of the Super PAC "Let's Fire Terrible Radicals Undermining Middle-Class People." It appears from your letter that the Commission is confused about the name of our Super PAC. The name of our Super PAC is "Let's Fire Terrible Radicals Undermining Middle-Class People." It does not include the name of any candidate.

We simply informed the Commission in our filing that the Committee intends to utilize the acronym TRUMP for Terrible Radicals Undermining Middle-Class People. The filing utilized the capital letters "TRUMP" and not the name "Trump" and expressly explained that "TRUMP" was intended to be the acronym—not the official name. The name of our Super PAC is **not** "Let's Fire TRUMP PAC (Trump is an acronym of Terrible Radicals Undermining Middle Class People)" as your letter seems to incorrectly indicate. To avoid any confusion, an amended form is submitted herewith.

Furthermore, while the Committee utilizes the acronym "LET'S FIRE TRUMP PAC," no reasonable person would confuse this PAC as being associated with the candidate Donald Trump. From its inception, the PAC's web site clearly and unequivocally stated "Not authorized by any candidate or candidate's committee." The PAC seeks to defend middle class people and opposes all terrible radicals who seek to undermine them. It is our opinion that Donald Trump simply states publicly what other Terrible Radicals Undermining Middle-Class People, like Jeb Bush, Marco Rubio, John Kasich, Ted Cruz, among others, privately think and will implement in public office if elected.

To avoid any confusion, our web site disclosure states:

"Paid for by the Let's Fire TRUMP PAC- A Special Project of the Let's Fire Terrible Radicals Undermining Middle-Class People PAC. Not authorized by any candidate or candidate committee. Contributions are not tax deductible."

This disclaimer tracks the disclaimer found acceptable by the Commission in MUR 6213, Decidedely Unhappy Mainstream Patriorts Rejecting Evil-mongering Incompetent Democrats Action Committee (DUMPREID PAC).

I trust that this letter, with the enclosed amended form, will clear any confusion that the Commission may have had regarding our PAC. We never intended, nor did we file a form, including the name of a candidate. We simply attempted to clarify to the Commission our use of the acronym TRUMP, which was unambiguously capitalized and followed by an explanation that it is simply an acronym of the full name, which was expressly stated on the form.


