This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **Failure to adequately respond by the response date noted above could result in an audit or enforcement action.** Additional information is needed for the following 3 item(s):

1. The beginning cash balance of this report does not equal the ending balance of your Mid Year Report (1/1/11 - 6/30/11). Please correct this discrepancy and amend all subsequent reports(s) that may be affected by the correction. (2 U.S.C. § 434)(b)(1))
2. The totals listed on Line(s) 6(c), 7, 11(a)(i), 11(a)(ii), 11(a)(iii), 11(c), 11(d), 15, 17, 19, 20, 21(b), 21(c), 29, 31 and 32, Column B of the Summary and Detailed Summary Page(s) appear to be incorrect. Column B figures for the Summary and Detailed Summary Pages should equal the sum of the Column B figures on your previous report and the Column A figures on this report. Please file an amendment to your report to correct the Column B discrepancies for this report and all subsequent report(s) which may be affected by this correction. Note that Column B should reflect only the Calendar Year-to-Date totals. (2 U.S.C. § 434(b))
3. Your report discloses debts to "LOUISVILLE & JEFFERSON COUNTY REPUBLICAN EXECUTIVE COMMITTEE" with opening balances totaling \$8,020.00. However, your 2011 Mid Year Report (1/1/11 - 6/30/11), indicates that these debts were paid in full on 6/28/11. Please amend your report or provide clarifying information regarding the current status of these debts. 11 CFR §104.3(d)
