Amendment in response to RFAI dated 5/5/2022 re APRIL QUARTERLY REPORT (01/01/2022 - 03/31/2022). Upon reviewing the RFAI and identifying the cause of the errors reported in Schedule A regarding election attributions/designations, the Committee reviewed 385 donor records at or near contribution limits dating back to the period covered by the OCTOBER QUARTERLY REPORT (07/01/2021 - 09/30/2021). The Committee discovered that several errors in both individual and PAC contribution reporting could be attributed to an error in the Committee's database default settings which caused contributions to be designated to 2021 versus the correct 2022. In addition, a review of scans and electronic records of the contributions from both individuals and PACs revealed that the designation as primary or general for several contributions did not match the expressed donor intent and required Corrections have been made to entries and reporting for seventeen (15) contributors: Amazon PAC. American Institute of Certified Public Accountants (AICPA PAC), American Optometric Association PAC, Ameriprise Financial PAC, Lakeitha Anderson, Charter Communications PAC, Albert Dotson, Ernst & Young PAC, Antoine Ezell, International Association of Firefighters, Iron Workers Political Action League, National Association of Mutual Insurance Companies PAC, Ally PAC, Target PAC, and United Health Group. Amendments are being filed for the OCTOBER QUARTERLY REPORT (07/01/2021 - 09/30/2021), YEAR END 2021 (10/01/2021 - 01/31/2022), APRIL QUARTERLY (01/01/2022 - 03/31/2022), and PRE-PRIMARY 2022 (04/01/2022 - 04/13/2022).
